



**Tenure-Track Faculty Position
Department of Electrical and Computer Engineering
Queen's University at Kingston, Canada**

Queen's University is situated on traditional Anishinaabe and Haudenosaunee Territory.

The [Department of Electrical and Computer Engineering](#) in the [Faculty of Engineering and Applied Science](#) at [Queen's University](#) invites applications for a **tenure-track faculty position at the rank of Assistant Professor with specialization in a field related to Robotics and/or Mechatronics Engineering, including, but not limited to, autonomous systems, machine learning & AI for robotics, intelligent systems engineering, human robot interaction, marine robotics, robotic perception & actuation or virtual reality/augmented reality.** The preferred start date is July 1, 2023.

Criteria:

The successful candidate must have completed a Bachelor's and a PhD degree in electrical engineering, computer engineering or a related discipline completed by the start date of the appointment.

The main criteria for selection are:

- Evidence of high-quality scholarly research expertise that complements existing research areas in the department that is demonstrated through peer reviewed publications and external research funding;
- Strong potential for outstanding teaching contributions at both the undergraduate and graduate levels, and an ongoing commitment to academic and pedagogical excellence in support of the department's programs; ability to teach electrical/computer engineering undergraduate courses such as electrical signals & systems, sensors & actuators;
- Provide evidence of their ability to work collaboratively in an interdisciplinary and student-centered environment;
- Professional engineering licensure in Canada, or the eligibility to obtain licensure, is a requirement. Note that all forms of engineering licensure in Canada are considered acceptable (e.g. P.Eng., temporary engineering license, provisional engineering license, etc.).
- Postdoctoral and/or industrial experience will be considered an asset;

Teaching at the undergraduate level will primarily support a new degree program in Mechatronics and Robotics Engineering jointly offered with the Department of Mechanical and Materials

Engineering. The successful candidate will be required to make contributions through service to the Department, the Faculty, the University, and/or the broader community. Salary will be commensurate with qualifications and experience.

Prior to May 1, 2022, the University required all students, faculty, staff, and visitors (including contractors) to declare their COVID-19 vaccination status and provide proof that they were fully vaccinated or had an approved accommodation to engage in in-person University activities. These requirements were suspended effective May 1, 2022, but the University may reinstate them at any point.

Queen's University is one of Canada's leading research-intensive universities with a global reputation and is a recognized leader in Canadian higher education. The Faculty of Engineering and Applied Science is home to the [Ingenuity Labs Research Institute](#), which brings together researchers whose research programs span from artificial intelligence and machine learning to robot control, smart sensors, and mechatronic devices. The Department of Electrical and Computer Engineering has 35 full-time and 7 cross-appointed faculty, 879 undergraduate students, and 200 graduate students. The University invites applications from all qualified individuals. Queen's is strongly committed to employment equity, diversity, and inclusion in the workplace and encourages applications from Black, racialized/visible minority and Indigenous/Aboriginal people, women, persons with disabilities, and 2SLGBTQ+ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority.

Applicants need not identify their country of origin or citizenship; however, all applications must include one of the following statements: "I am a Canadian citizen/permanent resident of Canada" OR, "I am not a Canadian citizen/permanent resident of Canada". Applications that do not include this information will be deemed incomplete.

In addition, the impact of certain circumstances that may legitimately affect a nominee's record of research achievement will be given careful consideration when assessing the nominee's research productivity. Candidates are encouraged to provide any relevant information about their experience and/or career interruptions.

A complete application consists of:

- a cover letter (including one of the two statements regarding Canadian citizenship/permanent resident status specified in the previous paragraph);
- a current curriculum vitae;
- a statement of research interests;
- a statement of teaching interests and experience (including teaching outlines and evaluations if available);
- a statement identifying their strengths and experiences with respect to increasing equity, diversity, and inclusion in their institutional environment
- three sample publications; and,
- the names and contact information of three referees.

Applicants are requested to send their application package electronically as a single PDF file to the Appointments Committee c/o Shelly Stilson, at ece-search@queensu.ca with the following subject line: Application for MRE Faculty Position. The deadline for applications is **January 15, 2023**;

however, applications will continue to be reviewed until the position is filled.
